Øivind Bratberg is a Political Scientist at the University of Oslo who completed his PhD in 2011 on the topic of British party politics following devolution. He has edited one academic volume on comparative political systems in Norway and the UK and is a co-author of *The Nordic Model of Social Democracy* (2013).

Nik. Brandal is a Historian at the University of Oslo whose research interests range from extremist political movements of post-war West Germany and the United States to the history and ideology of the Scandinavian labour movement. He is a co-author of *The Nordic Model of Social Democracy* (2013).

Ottar Brox is a former Professor of Sociology at the University of Tromsø and Senior Research Associate at NIBR (Norwegian Institute for Regional Research) in Oslo. He is a former Member of the Norwegian Parliament representing North Norway. He has published widely on Norwegian development issues over the long term, and a selection of his works was recently published as *The Political Economy of Rural Development: Development without Centralisation* (2006) (edited and introduced by John Bryden and Robert Storey).

John Bryden is a political economist, currently Research Professor at the Norwegian Agricultural Economics Research Institute in Oslo and Emeritus Professor of Human Geography at the University of Aberdeen in Scotland. He held the Chair of Human Geography at Aberdeen University between 1995 and 2004, when he was also co-Director of the Arkleton Institute for Rural Development Research. His other publications include *Tourism and Development; Agrarian Change in the Scottish Highlands* (with G. Houston); *Towards Sustainable Rural Communities* (University of Guelph); *A New Approach to Rural Development in Europe* (ed. with Keith Hart); *Towards Sustainable Rural Regions in Europe* (ed. with S. Efstratoglou, T. Ferenczi, T. Johnson, K. Knickel, K. Refsgaard and K. J. Thomson). He has also written many book chapters and journal articles on economic development, Scottish dependency, agrarian change, land reform, regional and rural policies, academic freedom, and on innovation in rural regions. Bronwen Cohen is Honorary Professor in the School of Social and Political Science at the University of Edinburgh, with over thirty years’ experience in social and educational policy and research at NGO, government and university levels, including twenty years as Chief Executive of Children in Scotland. Her current area of research is place-based learning in Scotland, Norway and the US, and her recent publications include ‘Developing ECEC Services in Regionalised

Keith Hart is Centennial Professor of Economic Anthropology at the London School of Economics, Co-director of the Human Economy Programme, University of Pretoria and former Director of the African Studies Centre, University of Cambridge. He was Senior Research Fellow at the Arkleton Institute for Rural Development Research in Aberdeen University, and has taught at the universities of Manchester, Yale, Michigan, Chicago and West Indies, among others. He is author of *The Memory Bank: Money in an Unequal World* (Profile Books, 2000) and editor of *The Human Economy* (2010: with Jean-Louis Laville and David Cattani).

Agnar Hegrenes is a Senior Agricultural Economist and Researcher at the Norwegian Agricultural Economics Research Institute who has written a number of book chapters and papers on Norwegian agricultural development and policy.

Mary Hilson is Reader in Nordic History at the Department of Scandinavian Studies, University College London, and Docent in Nordic Studies at the Centre for Nordic Studies, Helsinki University. In 2009, she was a guest researcher at Helsinki University affiliated to the Nordic Centre of Excellence: The Nordic Welfare States (NordWel). She has previously been a visiting researcher at the universities of Uppsala and Jyväskylä. She is the author of *The Nordic Model: Scandinavia since 1945* (2008) and co-editor (with Pirjo Markkola and Ann-Catrin Östman) of *Co-operatives and the Social Question: The Co-operative Movement in northern and eastern Europe (1860–1940)* (2012). She is currently working on a monograph about the co-operative movements in the Nordic countries 1860–1939.

Andrew G. Newby is Senior Research Fellow of the Finnish Academy, and Associate Professor in European Area and Cultural Studies at the University of Helsinki. He is specialist in the history and society of northern Europe in the nineteenth and twentieth centuries, and principal investigator of the research project "'The Terrible Visitation", Famine in Finland and Ireland, c. 1845–1868: Transnational, Comparative and Long-Term Perspectives.' He is the author of *The Life and Times of Edward McHugh* (2004) and *Ireland, Radicalism and the Scottish Highlands* (2007); and co-editor of *Michael Davitt: New Perspectives* (2009), *Language, Space and Power: Urban Entanglements* (2012), *Famines in European Economic History* (forthcoming, 2014) and *Ireland and Finland 1800–1923: Comparisons and Transnational Perspectives* (forthcoming, 2015).

Erik Opsahl is Associate Professor in the Department of Historical Studies at Norwegian University of Science and Technology (NTNU), Trondheim. Opsahl is a medievalist with a particular interest in Late Medieval Scandinavian History. He is one of the authors in *Norske Historie 750–1537 I & II* (1999/2007, 2003) and *Norsk innvandringshistorie I, I kongenes tid* (2003), and has written several articles on subjects including aristocracy, State formation, political culture, military history and national identity.

Tore T. Petersen is Professor in the Department of History, NTNU, Trondheim. His dissertation was on "'The Special Relationship that Never Was": The United States, Britain and France, 1953–1959'. Publications include *Richard Nixon, Great Britain and the Anglo-American Alignment in the Persian Gulf and Arabian Peninsula: Making Allies out of Clients* (2009/2011); *The Decline of the Anglo-American Middle East, 1961–1969: A Willing Retreat* (2006); *The Middle East between the Great Powers: Anglo-American Conflict and Cooperation, 1952–7* (London: Macmillan, 2000); *Challenging Retrenchment: The United States, Great Britain and the Middle East, 1950–1980* (2010); (with Clive Jones) *Israel's Clandestine Diplomacies* (2013). Forthcoming publications include *Power, Restraint and Influence: Anglo-American Relations in the Persian Gulf and Arabian Peninsula, 1978–1985* (2014); and *The Military Conquest of the Prairie: Native American Resistance, Evasion and Survival, 1865–1890* (2014).

Karen Refsgaard is an Ecological Economist who studied at the University of Copenhagen and the University of Life Sciences at Ås, Norway. She is a Senior Researcher at the Norwegian Agricultural Economics Research Institute in Oslo, where she leads the Grounded Innovation research group. Karen was co-author (with Ingrid Guldvik) of a chapter on Norwegian local governance for a recent book edited by B. S. Baviskar and A. Roy on local governance on five continents, published by ISR Delhi and the Government of India.

Lesley Riddoch is a journalist, author and broadcaster currently completing a PhD at Strathclyde University on the history of ‘hutting’ in Norway and Scotland. Lesley studied PPE at Oxford and was President of the Oxford Union. She is a popular journalist and broadcaster, her latest book being *Blossom*, about what Scotland needs to do to make life better for all, and referring to Nordic examples. In 2010, Lesley set up Nordic Horizons, an informal group of Scottish professionals who want to raise the standard of knowledge and debate about life and policy in the Nordic nations. The group holds public meetings in Edinburgh to allow Nordic specialists to discuss how they do things with decision-makers, practitioners, MSPs, academics and the interested public in Scotland. Wenche Rønning is Vice Dean for research and Associate Professor in pedagogy at the University of Nordland and Senior Researcher at Nordland Research Institute, both located in Bodø, Norway. In her research, Rønning has focused on issues concerning school in society, teacher-thinking and classroom research, and initiatives such as outdoor education and entrepreneurship in education. In her PhD she focused on active learning in the Norwegian context, historically, but also how teachers today interpret and view active learning in the current educational context.

Michael Rosie is Senior Lecturer in Sociology in the School of Social and Political Science at the University of Edinburgh, Director of the Institute of Governance, and Associate Editor of *Scottish Affairs*. His key research has centred around national identities, nationalism and (ir)religion, with a particular focus on Scotland and its UK neighbours. He is author of *The Sectarian Myth in Scotland: Of Bitter Memory and Bigotry* (2004), co-author of *Sectarianism in Scotland* (Edinburgh University Press, 2004), and serves on the Scottish Government’s independent Advisory Group on Tackling Sectarianism. Recent publications have focused on the ethnic boundaries of Scottish identity, on immigration and politics in Scotland, and on liaison models of protest policing.
